CITY OF ST. LOUIS PROPOSAL

Proposed Amendment to the Charter of the City of St. Louis

The City Council of St. Louis adopted a resolution to change regular City primary and general elections from odd to even numbered years. However, the Charter of the City of St. Louis still states that regular primary and general elections shall be held in odd numbered years.

The City Council is proposing that Charter Sections 3.2 and 3.3 be amended to correct the Charter and reflect the change in City elections from odd to even numbered years.

Shall the amendment as proposed be adopted?

VILLAGE OF ASHLEY PROPOSAL

Mosquito Control Millage Proposition

Shall the limitation on the amount of taxes which may be assessed against all property in the Village of Ashley, County of Gratiot, State of Michigan, be increased 0.5 mills (\$.50 on each \$1,000.00) on state taxable value for a period of four (4) years, 2024-2028, inclusive, which is estimated to raise \$4,159.00 in the first year, to fund periodic spraying for mosquitoes within the limits of the Village of Ashley.

FULTON SCHOOLS PROPOSAL

Fulton Schools Sinking Fund Millage Proposal

Shall the limitation on the amount of taxes which may be assessed against all property in Fulton Schools, Gratiot and Clinton Counties, Michigan, be increased by and the board of education be authorized to levy not to exceed 2.8442 mills (\$2.8442 on each \$1,000 of taxable valuation) for a period of 5 years, 2024 to 2028, inclusive, to create a sinking fund for the purchase of real estate for sites for, and the construction or repair of, school buildings; for school security improvements; for the acquisition or upgrading of technology; for the acquisition of student transportation vehicles; for the acquisition of parts, supplies, and equipment used for the maintenance of student transportation vehicles; for the acquisition of eligible trucks and vans used to carry parts, equipment, and personnel for or in the maintenance of school buildings; for the acquisition of parts, supplies, and equipment used to maintain such trucks and vans; and all other purposes authorized by law; the estimate of the revenue the school district will collect if the millage is approved and levied in 2024 is approximately \$882,070?
